## DECLARATION OF AUTHORISED OFFICER in accordance with Regulation 126 Fair Work (Registered Organisations) Regulations 2009

ALTERATION OF OTHER RULES OF ORGANISATIONS in accordance with section 159 of the Fair Work (Registered Organisations) Act 2009)

I, TIMOTHY DAVID WHYTE of 2/61 Bowen Street, Spring Hill QLD, am the Queensland District Secretary of the Construction, Forestry, Mining and Energy Union (Mining and Energy Division) and I am authorised to give this notice of particulars of alterations to the rules of Queensland District of the Construction, Forestry, Mining and Energy Union (Mining and Energy Division) and to make this declaration as required by Regulation 126 of the *Fair Work (Registered Organisations) Regulations 2009*.

- 1. I declare that the alterations were made in accordance with the rules of the Queensland District of the Construction, Forestry, Mining and Energy Union (Mining and Energy Division).
- 2. The particulars of the rule alteration are attached to this declaration and labelled 'Schedule A'.
- 3. The actions taken under the rules to make this alteration were as follows:
  - (a) On 22 July 2016 an agenda was prepared for the District Convention for the QLD Branch of the CFMEU (Mining and Energy Division) that was to be held on 22-26 August 2016.
  - (b) On 24 August 2016, as part of my report, I tabled a number of alterations to the rules as an agenda item as part of "general business." Copies of the summary and explanations of all alterations proposed was provided to convention delegates. Attached to this declaration and labelled 'Schedule B' is a copy of the summary and explanation of the rule changes proposed.
  - (c) Mr Alex Bukarica, CFMEU (Mining and Energy Division) National Legal Director, then spoke to the alterations to the rules. The convention determined that only one rule alteration would be voted upon, the change to Rule 7.
  - (d) On 26 August 2016 the District President read out the proposed alteration to Rule 7.
  - (e) Mr David Simpson moved a motion that the proposed rule 7 alteration be made to the rules. This motion was seconded by Mr Brian Wise.
  - (f) 10 delegates voted for the rule alteration and 6 voted against. As such the rule alteration was approved by the Convention lodge delegates as per Rule 7 (iii) (d) of current rule of the QLD District Branch.
  - (g) On 25 September 2016 I caused a copy of the proposed changes to the rules to be posted on the Union's web page. Attached to this declaration and marked "Schedule C" is a screen shot of the Union's web page.
  - (h) On 30 September I caused a copy of the minutes from convention to be sent to all lodges for endorsement, in accordance sub rule 7 (iv)(a) of the current rules. Returns from Lodge Secretaries indicated that an aggregate majority of members attending and voting at lodge meetings endorse the minutes from the Convention.
- 4. I declare that the particulars set out in this notice are true and correct to the best of my knowledge and belief.
