By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to lEBnominations@aec.gov.au. The subject line of your email should include the reference "E2023/158 – CFMMEU – Your Name"

Candidate Statements

Only statements which comply with the Rules and are received by the Returning Officer by 5:00pm (AEST) on 08/11/2023 can be accepted. Statements should be sent in a recognised Word format (such as .docx).
